

I am contacting you to extend an offer to have Pierce County Public Works and Utilities Solid Waste Division provide Junk Vehicle Affidavits (JVA's) for junk vehicles located on private property within your town/city limits. If you already have somebody providing this service and don't need our help please disregard this correspondence.


The JVA's are used when somebody wishes to have a junk vehicle removed from their property and they don't have title to the vehicle. Hulk haulers will not remove the vehicle without either; a title or a JVA. As you may be aware, without the proper paper work to have a vehicle removed it may end up sitting in the same spot for many years just becoming more of an eye sore. Or even worse, it may end up abandoned in the right-of-way or on some vacant lot left for the property owner to deal with.

In unincorporated Pierce County it used to be that issuing JVA's for vehicles on private property fell under the Sheriff's Dept.'s authority. Obviously, this task was very low priority for them. Since the Solid Waste Division is responsible for enforcing the Public Nuisance Vehicle Ordinance (PCC 8.10) violations on private property it only made sense for us to take over the responsibility of issuing JVA's for junk vehicles located on private property. So in 2004, we became certified Junk Vehicle Inspectors through the Dept. of Licensing. We now have the ability to help people get rid of that junk vehicle they don't own.

It has come to our attention that some of the incorporated cities and towns could also benefit from us providing this type of service. If so, please fill out the attached form and send it back to me in the self-addressed stamped envelope. Once I have received the form, we can then discuss a public outreach method to get the word out that this service is available.
