***For purposes of safety during this time, and the limited access to City Hall, sealed bids can be dropped off at City Hall in the drop-box located in the turnaround at City Hall.***

The bid should identify the vehicle identification number (VIN) and the amount the bidder is willing to pay for that vehicle. All sealed bids should be submitted to the City Clerk by 4:30 pm, Monday, March 22, 2021. The bid must include the bidder's name and contact information, including a phone number and/or email address.

**Viewing:** The vehicle may be viewed at City Hall, 2224 104<sup>th</sup> Avenue East, Edgewood, WA beginning Wednesday, March 10, 2021 through Tuesday, March 16, 2021 (excluding the weekend) between the hours of 10:00 am and Noon using social distancing requirements.

**Bid Opening:** The bid opening will be conducted by the City Clerk at Edgewood City Hall on Tuesday, March 23, 2021 at 9:00 am in the Council Chambers. Because City Hall is closed to the public, bids will be uploaded to the website for viewing. The sale of the vehicle shall be awarded to the bidder who submits the highest bid (over the minimum bid listed above). The bid award shall be made at the conclusion of the bid opening.

**Sales Terms:** Vehicles are sold as is. Payment shall be made for the full bid amount via cash, credit card (there is a 3% service fee charged) or certified check payable to the City of Edgewood. Payment must be received by the City by 4:30 pm, Wednesday, March 31, 2021. Failure of timely payment will result award of the sale of the vehicle to the next highest bidder, with payment from such bidder due within 24 hours of notice from the City Clerk's office via phone or email.

**Delivery:** Delivery of the vehicle will take place directly after payment is received and title is transferred. A Driver's License, Passport or Birth Certificate will be required to authenticate buyer's identification for title transfer purposes.

The City reserves the right to reject all bids and dispose of the vehicle as determined by the Mayor. Please direct any questions you have about the process to the City Clerk's office.
