The attention of all prospective bidders on the above project is directed to the following additions and modifications to the Contract Provisions and Contract Plans.

# I. <u>ADDITIONS, MODIFICATIONS, AND/OR DELETIONS TO THE CONTRACT PROVISIONS</u>

#### **ITEM 1: BID DATE REVISION**

The bid opening date is revised to 12:00 P.M. (local time) on Wednesday, September 22, 2021. All references in the contract provisions to the bid date and/or bid opening time shall be replaced with the revised bid opening date.

#### **ITEM 2: SCHEDULE A REVISION**

Schedule A is hereby revised, replacing Page P-2 with the attached version.

#### ITEM 3: BID ITEM #10 (Crushed Surfacing Top Course (4-04))

Bid item #10 quantity is revised from 143 TN to 25 TN, and shall include all CSTC needed for work within the streets (including widening). Any shoulder rock shall be incidental to

bid item #19, described below. There are no changes to the title, specification references or special provisions for this item.

#### ITEM 4: BID ITEM #11 (HMA CL. ½ in. PG 58H-22" (5-04))

Bid item #11 quantity is revised from 95 TN to 85 TN, and the title has been appended to note this item includes HMA for the widening and overlay activities. There are no changes to the specification references or special provisions for this item.

#### ITEM 5: BID ITEM #19 (Ditch or Shoulder Restoration (8-02))

Bid Item #19 is hereby added to Schedule A, as shown on the attached Page P-2. Measurement and Payment will remain as stated under the notes in the Contract Plans.

#### **ITEM 6: ROADWAY EXCAVATION**

There is no bid item for roadway excavation under Schedule A. Any excavation, removal and disposal shall be incidental to the HMA work under bid item #11.

#### II. <u>ADDITIONS, MODIFICATIONS, AND/OR DELETIONS TO THE CONTRACT</u> PLANS

#### **ITEM 1: GRAVEL BASE (TYPICAL SECTION)**

There is no bid item for gravel base under Schedule A. In storm drainage trench locations, gravel base may be provided as trench backfill, which is incidental to bid items 12 and 13. In lieu of any other import gravel base material, it is assumed that native material left in place will be suitable.
