**By signing this agreement I understand that I have read and agree to the following:**

- I understand that it is my responsibility to **renew this agreement annually.**
- I understand if I do not maintain the vegetation, this agreement becomes null and void, and said right-of way will be returned to the current Vegetation Management Program.
- I understand if I request the City of Edgewood to not cut or spray the right-of-way adjoining my property, then it becomes my responsibility to maintain the vegetation along said right-of-way.
- I understand that this agreement applies only to mechanical vegetation control (brush cutter/grass mower) and the herbicide application. This does not apply to the overhead Vegetation control.
- I agree to post the "Owner Maintain" signs on the borders of my property so the signs will be clearly visible from the driving lane.
- I agree to control the vegetation on the right of way, including alder, willow, blackberry, scotch broom, Douglas fir, and noxious weeds. Vegetation should not hinder traffic visibility nor encroach into the roadway surface or shoulder area.
- I hereby accept the responsibility to install and maintain the "Owner Maintain" signs in the manner and at the locations set forth in this agreement. I further agree my performance under this agreement is at my sole risk, and I shall indemnify the City of Edgewood, its agents and employees, and hold them harmless from any and all liability for damages, costs, and expense resulting from, arising out of, or in any way connected with this agreement, or from my failure to perform fully thereunder. I further agree to defend the City of Edgewood, its agents and employees, against all suits, actions, or proceedings brought by any third party against them for which I would be liable thereunder.
