The appeals were consolidated and processed under Pierce County Cause No. 11-2-12496-2. The Superior Court's November 10, 2011, Findings of Fact, Conclusions of Law and Decision on Appeal ordered the City to conduct a new final assessment hearing limited to these parcels. Unless the Superior Court's decision is reversed on appeal or a particular landowner withdraws his/her legal challenge, the final assessment amounts for these parcels will be determined after this hearing and any related confirmation processes have occurred.
